#### **Guiding Principles Declaration**

We are fully committed to safeguarding children and young people in line with Children First: National Guidance for the Protection and Welfare of Children (2017). We pledge to:

- Comply with all national legislation and best practice guidelines for child safeguarding.
- Implement and regularly review our child safeguarding procedures to ensure they remain effective and up-to-date.
- Provide clear policies for parents, guardians, and staff to ensure transparency in how we protect children.

#### Categories of Abuse and How They May Be Recognized

As outlined in Children First National Guidance (2017, Chapter 2, pp. 7-11), child abuse falls into four main categories:

- 1. Neglect Persistent failure to meet a child's basic needs, including food, shelter, emotional support, or supervision.
- 2. Emotional Abuse Persistent emotional ill-treatment that affects a child's self-esteem and

development.

- 3. Physical Abuse Deliberate injury or harm to a child, such as hitting, burning, or shaking.
- 4. Sexual Abuse Forcing or enticing a child into sexual activities, whether physical or non-contact.

Procedure for Reporting Child Safeguarding Concerns

All safeguarding concerns must be reported to Tusla (Child and Family Agency) and, where necessary, An Garda Síochána.

- Who to Contact: Tusla Designated Liaison Person (DLP) or An Garda Síochána if a child is at immediate risk.
- What to Include in the Report: Child's details, nature of concern, any evidence or disclosures.
- How Parents Will Be Informed: Parents/guardians will be informed unless doing so would place the child at further risk.

Immediate Risk of Harm to a Child

If a child is at immediate risk of harm:

- Contact Tusla immediately in my region.
- Contact An Garda Síochána at the local station if necessary.
- Complete a Standard Report Form (SRF) for Tusla.

### Review & Compliance

I commit to reviewing this policy annually and updating procedures in line with changes to Children First National Guidance and Tusla recommendations.
